## Oceanside Senior Anglers, Inc.

The club was formed in 1994 to provide a sport fishing outlet to seniors of Southern California and elsewhere. In 2011 OSA formally incorporated as a 501 (c) (7) non-profit fishing organization. The club is open to senior's age 50 years or older. OSA has grown steadily year by year. We have close to 360 members and almost 640 including spousal members. Club angling activities are centered around saltwater fishing. In addition, we hold social events including numerous picnics and an annual banquet, as well as various events to raise funds for Kids, Military and Scout trips that we host. We understand that the Oceanside Senior Anglers club is one of largest fishing clubs in California. The Club has a conservation policy that encourages all members to follow on club trips and on any other fishing trips that they participate in.

We are primarily saltwater oriented, with fishing trips ranging from 3/4 day inshore to multiday charters pursuing pelagic species. We negotiate and charter a sportfishing boat for each of our scheduled trips. We consistently average around 20 club charter trips each year, primarily out of San Diego, and may add more as the year progresses. In addition to the club sponsored fishing trips, individual club members organize numerous side trips throughout the year, generally with fellow members, to Baja and mainland Mexico and further afield to Alaska, Canada, Florida, Costa Rica, Louisiana, Panama, Puerto Rico and even to the Amazon.

On the social front we have various picnics throughout the year. These are a great opportunity for members and their guests to enjoy some great food at absolutely rock-bottom prices and more importantly, they provide an opportunity – especially for spouses – to mix & meet other club members in a non-fishing environment. We plan for eight to ten events annually, including an American Picnic, Italian Fest, Irish Feast, Pig Roast, Cioppino Fest, Fish Fry, October Fest, Clam Bake, and Shrimp Boil. At year's end we have an annual Christmas banquet held in the Oceanside area. At the annual banquet, the new club officers are installed, awards and prizes are given, and a good time is had by all.

Every year we sponsor and conduct as many Anglers 4 Kids fishing trips as our funds allow, where we can take up to 30 kids per trip from area Boys & Girls clubs, Military YMCA, and other deserving organizations on a chartered boat, generally out of Oceanside or San Diego. We also conduct our Anglers 4 Military fishing trips for wounded servicemen and women from Camp Pendleton Wounded Warrior Battalion and Balboa Naval Hospital. We plan for four Anglers 4 Kids trips and three Anglers 4 Military trips each year. We also support our Anglers 4 Scouts program, where we provide fishing equipment to the Boy Scout Camps in and around San Diego.

The club raises funds for our programs at the annual Fred Hall Show, Oceanside Harbor Days and member donations. Members volunteer to support the clubs booth at these fund raising activities.

Club meetings are held on the first Tuesday of every month from 9:00 am to 11:30 am at the Oceanside Senior Center, located at 455 North Country Club Lane in Oceanside. At each meeting well known and knowledgeable guest speakers are scheduled to cover areas such as fishing destinations, fishing tips for local, offshore and long-range fishing, equipment maintenance, fishing tackle, conservation and specific information on different fish species. Guests interested in joining are welcome at our meetings. The membership dues are \$30 per year for renewals or new members, plus an extra \$15 if the monthly Fish Tales newsletter is received as hardcopy by mail, rather than via email or via the web, in which case there is no additional charge. Membership application/renewal/update link is located on the Contact Us tab of the clubs website. The form can be downloaded and printed. Follow the directions on the form to join, renew or update information.

#### **CONSTITUTION AND BY-LAWS**

#### **ARTICLES**

The name of the club is the Oceanside Senior Anglers, Inc.

This club is formed for the mutual pleasure fraternity and participation of the members in the sport of fishing, both Inland and Ocean.

This club shall be a non-profit club. No profits or gains shall be given to any member. Upon dissolution, the Board of Directors shall give all monies and/or assets to any organization with a worthy charitable program.

The Board of Directors shall consist of five (5) elected officers, consisting of the President, Vice President, Secretary, Treasurer, and Head Charter Master, along with three k(3) directors appointed by the newly elected President, consisting of the Director of Program Functions, Director of Social Activities, and Director of Membership. The remaining Director shall be the current Past President, making nine (9) Members of the Board in all. Each Member of the Board of Directors is entitled to a vote at the Executive Board Meetings.

The qualifications of the members, voting, and other rights, privileges, and obligations of members shall be shown in the By-Laws.

#### **BY-LAWS**

- 1. Meeting Place The principal meeting place and office shall be the Oceanside Senior Center, 455 Country Club Lane, Oceanside, but at the discretion of the Board of Directors, may be changed from time to time as required.
- 2. Qualifications of Membership, Rights and Privileges The membership in this club shall be limited to any adult meeting the membership requirements of the Oceanside Senior Center of fifty (50) years or older. In the event of the death of a member in good standing, the spouse may continue as a member of the club regardless of age.
- 3. Dues The Board of Directors shall determine the amount of dues each year, as appropriate for conditions existing at the time. Dues are payable October 1st each year, and if not paid by December 31st shall cause the member to be delinquent. The Club's representative will attempt to contact all delinquent members to determine if they are renewing membership or not.
- 4. Delinquent Dues Dues not paid by the first of January shall cause the membership to be terminated and the member's name deleted from the roster.

- 5. Voting Rights Each member shall be entitled to vote on those matters submitted to the membership for action and approval.
- 6. Guests Members desiring to invite guests for trips and other activities shall make a request in advance to the chairman of the specific activity. Minor guest privileges can be given at the discretion of the chairman of the event. All guest privileges shall be the responsibility of the inviting member.
- 7. Meetings General membership meeting shall be held at 9:00 a.m. on the first Tuesday of each month at the Oceanside Senior Center. No written or other notice shall be required unless there is a change by the officers of the club.
- 8. Quorum The presence in person at the meeting of one fifth (1/5) of the membership shall constitute a quorum for the transaction of the business by the members of the club.
- 9. Duties of the President The President shall preside at all meetings and shall make appointments to all committees.

The President shall appoint alternate officers where a vacancy occurs.

The Vice President shall act in the absence, or incapacity of the President.

The Head Charter Master shall act in the absence, or incapacity, of the President and Vice President.

The Recording Secretary shall keep the minutes of all meetings of the club and shall perform such other duties as the President may direct.

The Treasurer shall receive and account for all moneys and shall deposit same in the bank designated by the officers for the club. The Treasurer shall present an itemized statement at each meeting.

- 10. Election of Officers The officers shall be elected at the November meeting and installed at the December meeting, with the exception of the Head Charter Master, who shall be elected at the September meeting to assume duties immediately. Officers shall continue in office until their successors are duly elected and qualified.
- 11. Nominating Committee The President shall appoint a nominating committee at the June meeting. Nominations shall be reported at the October Meeting.
- 12. Amendments This Constitution and By-Laws may be amended at any regular meeting by two-thirds (2/3) vote of members present and voting, provided that notice of the proposed amendment shall have been read at the preceding meeting.
- 13. Property Rights upon termination If any member shall cease to be a member, any interest he/she shall have in or to the property or assets of the club and all membership privileges shall cease and revert to this club.

Order and Procedure – All questions of order and procedure not specified herein shall be in accordance with the Robert's Rule of Order, newly revised.

## **Discrimination Policy**

The Oceanside Senior Anglers Club is committed to the principle that all members shall have equal access to programs, services and events without regard to personal characteristics.

The Oceanside Senior Anglers prohibits discrimination, harassment or bullying of any person because of ancestry, color/ disability or handicap, age, national origin, race, religion, gender, sexual or affectional orientation, gender identity, appearance, political affiliation, marital affiliation, marital status, veteran status or any other characteristic protected by law.

The Oceanside Senior Anglers expects all members, volunteers and constituents of the Oceanside Senior Anglers when and where ever those individuals are conducting Oceanside Senior Angler business or participating in Oceanside Senior Angler events or activities, shall maintain an environment free of discrimination, including harassment or bullying.

Oceanside Senior Angler policy also prohibits reprisal or retaliation against any person in any of its programs or activities for making a complaint of discrimination or for using or participating in the investigation or resolution process of any such event.

Oceanside Senior Angler policy is intended to be consistent with the provisions of applicable of State and Federal laws. Inquiries regarding the non-discrimination policy may be directed to the President of the Oceanside Senior Anglers Club.

#### **Code of Conduct**

The purpose of this Code of Conduct is to provide Oceanside Senior Angler (OSA) members, family members, guests or visitors guidance in the club conduct policy which is in force at all OSA activities. The guidelines are to ensure everyone can enjoy the activities coordinated by OSA in a safe, responsible, and respectful manner.

It is expected that all members, family members, visitors, and guests will be treated fairly, equally, and with respect. We will enforce the right for all OSA members to enjoy their Club in an environment that is safe, free from all forms of harassment, discrimination, and offensive language and without risks to health, violence and aggression. If you experience or witness any of the following behavior, for example, at any OSA event please report it immediately to an OSA member in charge.

Racism
Sexism or Sexual Harassment
Verbal or Physical Abuse or Bullying
Alcohol abuse
Drug abuse
Religious Intolerance
Offensive or Obscene Language

The inappropriate behavior of any member will be investigated, reviewed and discussed, and an appropriate course of action will determined and voted on by the Board of Directors. Any violation of this Code of Conduct will result in the offending member being removed from the event, where feasible, and any severe breaches of

the Code of Conduct or unlawful activity will result in immediate Dismissal/Termination of the member up to and including notification to law enforcement, and a life-ban from OSA events. Multiple offenses will result in Dismissal and Termination of the membership, and a life-ban from OSA events.

#### **Conservation Guidelines**

#### Enhancing Our Sport through the Stewardship of all Fisheries



The Oceanside Senior Anglers has always promoted conservation in all of its activities and with all of its members. The club has adopted a conservation policy as a cornerstone of its efforts to learn, educate and communicate the importance of conservation with all of its members. The conservation policy is as follows:

The Oceanside Senior Anglers are committed to the conservation of fishing resources in order to maintain and improve the quality of our sport fishing activities. Club members and guests are expected to:

Comply with all relevant fishing regulations for club charters and side trips.

Carefully handle and release fish that are alive, either prohibited by fishing regulations, unwanted, or are not needed for consumption.

Avoid any actions that might have a detrimental effect on the aquatic environment.

Promote good conservation practices with fellow members and others through education and example.

The intent of our policy is to state a principle and position for the club. The club does not intend to try to enforce this policy, this is not our business. As in most areas, ultimately it is up to the individual to do what is right. Members can assist by speaking up when you see a member or guest causing a conservation concern. The person may not know there is a problem. If they do know they may not know how to resolve the problem. Set good examples and show other members how to improve conservation compliance by practicing good conservation ourselves. Do it yourself and don't rely on the deckhand to safely release your fish. If he has time and is willing to help that is great, but each member is expected to be capable of safely releasing his or her own fish. Please feel free to ask questions. If you know the conservation requirement but don't know how to achieve it then please ask for help.

OSA has established a fishing line recycle program, whereas members bring their used line to monthly meetings and the line is collected and sent to a recycling program that turns the used line into freshwater habit structures

#### **Anglers 4 Kids**

Oceanside Kids Fishing trips initially began during the years of 1997 thru 1999 whereby some of our club members supported kids fishing trips out of Seaforth Landing. OSA members volunteered their time and fishing knowledge, assisting the Captain of the Seawatch and Friends of Rollo that provided Kids Fishing Seminars and hands on fishing education. In 2000 OSA members decided to provide a one day trip each summer that was fully sponsored and paid for by the club. Club members held fund raisers, provided donations and volunteered their time so that kids ages 6 to 15 were able to have the opportunity and experience of ocean fishing; many for the very first time.

The Club continued one trip each summer until 2003 when OSA obtained additional funding from the San Diego Fish & Wildlife Commission. With funds the club received from donations along with grant funding from the San Diego Fish & Wildlife Commission, the club was able to increase the number of summer fishing trips for kids to four, half day trips out of Seaforth Landing. Starting in 2007 OSA was able to provide four; individual 3/4 day kids trips with the Sea Star, located at the Oceanside Harbor. This increased the club's ability to provide more time teaching and educating kids on proper Boat Procedures, Ocean Safety, Rod & Reel Training, Live Bait handling, Government Legal Size Fish (Keepers) & Limits, Clean Ocean Environment Protection, and very importantly Ocean Conservation Education. Each kid is provided with a booklet "Let's Go Fishing" that summarizes the information that has been presented to them on their fishing trip. On these trips we further provide meals, soft drinks, and a trophy to each kid that identifies all kids being winners and a remembrance of their trip experience. The majority of kids we sponsor are from North County Boys & Girls Clubs located in Oceanside, Vista, San Dieguito, Carlsbad, Escondido, Poway and Ramona. Additionally, we set aside trips for kids from Camp Pendleton YMCA along with Summer Camps from Escondido, San Marcos, and Vista. Many of these youngsters are from single parent households. Since the Oceanside Senior Anglers Kids Trips have been established, we have provided over 2000 kids the opportunity to realize the pleasure of open sea fishing and the great joy nature presents.

#### **Oceanside Senior Anglers Kids Trip Motto Is:**

"Old Kids Helping Young Kids"

#### **Anglers 4 Military**

In 2007 our club started a program to recognize our military "wounded warriors" who suffered injuries serving our country. To accomplish this we receive donations from our club members and the Escondido Rotary Club. We are able to hold three fishing trips (¾ day) for twenty-five (25) warriors on each trip.

Our Heroes came from Camp Pendleton Wounded Warrior Battalion and Balboa Naval Hospital in San Diego. We have continued this program each year and plan on its continuation into future years. We charter boats (whose owners were very gracious) from the Oceanside Marina to Point Loma Landing.

There are absolutely no costs for those who attend. They are furnished with everything that they need for the day including food, fishing license, and equipment. Depending on donations our goal for each year is for at least three trips. This is so we can show in some small way; a thank you to our Country's heroes.

We also support the Fisher House located at Camp Pendleton. The Fisher House Foundation is best known for a network of comfort homes where military and veterans' families can stay at no cost while a loved one is receiving treatment.

#### **Anglers 4 Scouts**

The Scouts program supports local BSA council summer camps by providing a variety of salt and fresh water fishing tackle. Our members volunteer each summer to support the scouts in training and equipment fishing maintenance. In 2016, our equipment donations supported over 2500 scouts.

#### **OSA Trip Sign Up Guidelines**

- 1. Charter trips will be open for general sign up on a staggered basis, beginning at a general club meeting at least 3 months prior of the scheduled trip. These dates will be published in the official trip schedule and on the club website.
- 2. A maximum of one-third (1/3) of the allotted number of anglers for each trip will be allowed to register with the trip Charter Master before the trip is open to club at the general meeting. The 1/3 includes the trip Charter Master and the assistant chosen by him/her. For example:

Trip anglers 15-16, max pre sign ups = 5

Trip anglers 20 or 21, max pre sign ups = 7

Trip anglers 30, max pre sign ups = 10

3. After signing up, anglers have 7 days to pay the full amount due. Failure to do so may result in being canceled off the trip.

To avoid disappointment, it is strongly urged that payment in full be made at the time of all sign ups.

- 4. If a member cannot be present at a meeting, another member (but NOT the trip Charter Master) may sign up on their behalf. Any one member can sign up a maximum of 4 people, including him/her. **Signups on behalf of others must be paid for at the time of sign up**.
- 5. Payment for trips must be given to the trip Charter Master. Trip money should NOT be sent or given directly to the Treasurer. You must be on the sign up list.
- 6. If an angler who has signed up cannot make the trip for any reason, the angler must notify the trip Charter Master as soon as possible. It is the canceling angler's responsibility to find a substitute, in order from the list of alternates that will be provided by the trip Charter Master. If there are no alternates, the trip is considered 'open' the angler can either find someone (member or guest) to fill in, or may ask for assistance in notifying the general club membership of the opening. The canceling angler is also responsible for arranging reimbursement from the substitute. If no substitute is found the club will NOT reimburse, except in exceptional circumstances, as decided by the board.

7. After the annual trip schedule is firmed up, usually early January, a chartermaster meeting & training seminar will be held and chaired by the head charter master (HCM). All members who wish to be considered for trip charter master (CM) during the upcoming season are required to pre-register for the meeting. The HCM will clarify current club guidelines and procedures that are relevant to be being a trip CM. The HCM will subsequently assess all candidates and notify those selected. Trips will be assigned to each CM based on a mutual understanding of dates and type of trip.

#### **OSA Tuna Trip Guidelines**

- 1. Troll with minimum of 100 yards of mono top shot over spectra.
- 2. Troll with no less than 60 pound test line, includes mono top shot.
- 3. Use your trolling number as your position, moving one space to the right each turn.
- 4. Notify the Charter Master if you do not want to troll. The Charter Master will be the one to find your replacement.
- 5. When hooked up, reel in your fish as quickly as you can.
- 6. Do not cast live bait next to a trolling rod when the angler is bringing in their fish. [For further trolling guidelines, see page 12 of this document]
- 7. Bait Sticks: Top shot is optional, but recommended. It is recommended that 25-50 ft of mono top shot be used. Spectra/Braid does not stretch; the top shot will act as a shock absorber.
- 8. Know the tuna 2-step, (for our seniors, Dancing with the Stars)
- 9. Cast live bait from downwind & work your way up wind.
- 10. Keep the wind in your face. (Wind in your Face, you're in the Right Place)
- 11. Follow your line; keep it in front of you. (No Angles No Tangles)
- 12. When casting always keep your eyes on your hook!!!!
- 13. Cast irons, jigs and poppers from bow only.
- 14. Communicate in a calm and courteous manner with fellow anglers. (Remember you're on the trip to have fun)
- 15. Be aware of what is going on around you, Safety First.
- 16. Give the right away to the angler with a fish on.
- 17. Only one rod in the first 10 holders per side, please place remaining rods forward.
- 18. Remember which rod holder you take.
- 19. You are responsible for you own fish, from hook to bag.

Any problems please inform trip Charter Master.

### **Enjoy Your Time on the Water**

#### **OSA 3/4 Day Trip Guidelines**

- 1. When live bait fishing, there is no minimum of mono top shot over spectra.
- 2. When casting always keep your eyes on your hook!!!!
- 3. Casting with irons is done from the bow only.
- 4. When you're not fishing, remove your rod from the rail. No saving of a spot.
- 5. Stay within your color group.

- 6. Follow your line; keep it in front of you, and stay within your group.
- 7. You are responsible for you own fish, from hook to bag.
- 8. Never bring a Sculpin over the rail. Let the crew know you have a "rattlesnake".
- 9. The 'Fish Descender' will be available. Members are to work it themselves.
- 10. Be aware of what is going on around you.
- 11. Any problems please inform trip charter master.
- 12. Rotations will be 40 minutes. The Charter Master is responsible for the time keeping.

#### **Jack Pot Rules**

- 1. Entering the Jack Pot is optional.
- 2. The Trip Charter Master is responsible for the enforcement and interpretation of club rules.
- 3. Any edible legal fish except sharks, rays or eels, are eligible provided the angler has bought into the jackpot and fish is legally caught.
- 4. No fish caught at the bait barge or when making bait are eligible.
- 5. No troll fish caught is eligible.
- 6. The Angler must cast their own bait or lure.
- 7. No handoffs by other anglers or crew will count whether or not a fish has been hooked at the time of the handoff.
- 8. The fish must be hooked and landed or brought to gaff by the angler, except for assistance from the crew in clearing line tangles or boat lines or going around the anchor.

The Charter Master, with the help of the crew, will determine the winner, and will in turn announce same. Any eligible fish should be brought forward by the angler immediately.

#### **OSA Trolling Guidelines**

- 1. Everyone will be assigned to a trolling team. A team consists of four (4) anglers. Your sack number will be your assigned number which determines what team you are on. Remember which one you are on.
- 2. Troll only when it is your turn. If you do not want to troll, let the CM know. (see # 8)
- 3. Any fish caught while trolling does not count in the jackpot.
- 4. When you are trolling stay with your troll pole at all times. If you must leave for a short time (bathroom, etc.) make sure that you have someone who will take over and handle your rig.
- 5. Troll with heavy trolling equipment. The minimum test line will be 60 lbs. Spectra with a top-shot of at least 100 yards of mono is required.
- 6. Do not abandon your trolling pole and start fishing with another pole (bait rod) until you have the troll pole completely reeled in and put in a safe & secure holder.
- 7. Stay alert as to what your lure and line are doing.
- 8. When it is your turn to troll and you do not want to, please advise the Charter Master. The Charter Master will then assign someone to the spot. Our goal is to make sure that everyone will catch fish. After everyone has at least one targeted fish on board then the rule can be relaxed.
- 9. The goal is for all of us to catch fish. If there are vacant trolling spots, the Charter Master may first assign them to folks who have no fish, then to those who want them.

- 10. Trolling teams will change rotation after the following occurs:
  - No one on the troll team hooks up and or catches a fish after allotted troll time (30-40 minutes). The Charter Master will keep the time.
  - If you get a strike and the fish does not hook (hit and a miss) the team will continue the troll.
  - If you get hooked up but lose the fish during the fight, your team's turn will be up.
  - If you catch any fish (either targeted or NON-targeted) your team's turn will be up.
- 11. Remember, when the skipper starts a troll, make sure you stay alert as to which team is up. The boat's crew is there to help you and please let them do their job in assisting you if required with setting up the troll pattern and the associated things that will increase our chance of success.
- 12. When hooked up, retrieve the line as fast as you can. Stay in front of your fish at all times by sliding left or right along the rail so your line goes straight out from the boat and not on an angle.

#### **OSA Policy for Club Record Fish Catches**

The club will only keep records on targeted game fish caught along the Pacific Coast from Alaska to the tip of Mexico for Class 1 and Class 2 trips, excluding billfish, rays and sharks to avoid having to kill or estimate the weight.

Class 1 trips will be for all Oceanside Senior Angler charters and Class 2 trips will be for all others. Applications for a species record must be submitted on the "Species Record Application" form available from the Head Chartermaster and on the OSA website, within the year it was caught. An application can only be made by a current member in good standing and must be signed by a witness and be accompanied by a picture of the fish. After the form has been completed it should be submitted to the Head Chartermaster for verification and approval.
